

Baggage Certificate

It is mandatory to send all requested documentation

- Completed request for the issue of a Baggage certificate (Form attached)
- List of personal belongings to be transported and imported into Portugal
- Proof of residence in the UK for more than 1 year (e.g. payslips, GP registration, bills of water/electricity/gas)
- Proof of cancellation of residence in the UK (e.g. cancelling GP registration, closing accounts for water/electricity/gas)
- Declaration on the establishment and cancellation of residence in the UK and transfer of residence to Portugal (Form attached)
- Declaration that the personal belongings to be transported and imported to Portugal were acquired more than 6 months prior to the date of cancellation of the UK residence, were used at that residence and are intended to be used at the new habitual residence in Portugal (Form attached)
- Copy of ID Card/Passport
- Copy of the residence permit in Portugal (in the case of foreign nationals)
- International Cheque in Pounds (if the certificate is to be sent to a Portuguese address) or Postal Order (if the certificate is to be sent to a UK address)
